International plc exceeding the notification threshold of 10% in Unieuro S.p.A. was made in the context of facilitating client related activity and in line with our normal course business. The acquisition was financed by a combination of external and Morgan Stanley own funds.</p>			
<p>b) whether acting alone or in concert:</p> <p>Morgan Stanley & Co. International plc is not acting in concert with any party outside of the Morgan Stanley Group of companies.</p>

This may result Morgan Stanley & Co. International plc's holdings exceeding/falling below the relevant threshold of 10% from time to time, without entailing any change in the intentions declared in this statement.</p> <p>Morgan Stanley & Co.
